WHEREAS, under the Disaster Mitigation Act of 2000, the United States Federal Emergency Management Agency (FEMA) requires that local jurisdictions have in place a REMA-approved hazard Mitigation Action Plan as a condition of receipt of certain future Federal mitigation funding after November 1, 2004; and

WHEREAS, the County of Fort Bend and its municipalities, in order to meet this requirement, have initiated in the development of a regional, multi-jurisdictional Hazard Mitigation Plan covering 17 municipalities including the City of Weston Lakes; and

NOW, therefore be it resolved, that the City of Weston Lakes City Council

HEREBY:

- (a) Adopts the Fort Bend County Mitigation Action Plan
- (b) Authorizes the Fort Bend County Judge to appoint members to the Fort Bend County Hazard Mitigation Team to assure that the Mitigation Action Plan be reviewed at least annually and that any needed adjustment to the Mitigation Action Plan be developed and present to the Commissioner's Court and City Councils for consideration.
- (c) Agrees to take such other action as may be reasonably necessary to carry out the objectives of the Mitigation Action Plan.


