Section 2. Numbering of Prior Ordinances.

Section 3. Numbering of Future Ordinances.

All future ordinance numbers will follow the format below.

Ordinance XX-YYYY

“XX” referring to the sequential number of passed ordinance of the year; additional digits past two may be added as needed. “YYYY” Referring to the Gregorian calendar year additional digits past four may be added as needed.

Section 4. Severability.

If any section, subsection, sentence, clause, phrase, or portion of this Ordinance shall be declared unconstitutional or invalid by a court of competent jurisdiction, such declaration shall not affect the validity of the remaining portions of this Ordinance.

Section 5. Effective Date.

This Ordinance shall take effect immediately upon its passage.
