**Section 4. Severability.**

If any section, subsection, sentence, clause, phrase, or portion of this Resolution shall be declared unconstitutional or invalid by a court of competent jurisdiction, such declaration shall not affect the validity of the remaining portions of this Resolution.

**Section 5. Effective Date.**

This Resolution shall take effect immediately upon its passage.
